Hi Ms. Fontaine:

Please see below our response to Clarification II of the referenced RFP.

1. Please provide clarity on the minimum amount for delivery prior to penalty is by each terminal or in totality to the Authority. Question: VIWAPA stated an average of 330,000 per year in your proposal you have based an initial penalty looking at a total delivery of 360,000Bbls per year. Was this an error/oversight? Also confirm the differential cost base on the Authority average as stated above.

Response: Our pricing considers minimum deliveries of 30,000 bbls. It is the most efficient way to deliver small barge quantities to the WAPA terminal. Therefore, the shipping penalty is based on a per delivery basis, and not on an annual volume basis. On a related note, our Tank Lease proposal helps avoiding most of these penalties.

2. The date for the proposal(s) has or is about to expire, please review submittals and resubmit with a new expiration date(s).

Response: We could extend the validity of our proposal until December 31, 2024.
