**AMENDMENT I**

This Amendment I to Contract SC-11-22 is hereby entered into this the 16 day of August 2022 between the **VIRGIN ISLANDS WATER AND POWER AUTHORITY** (herein referred to as the "Authority") and **ARCADIS, U.S., INC.** (herein referred to as the "Contractor"). The Authority and the Contractor shall hereinafter be jointly referred to as "the Parties."

**WHEREAS**, on January 27, 2022, the Parties entered into Contract SC-11-22, wherein the Contractor agreed to provide a Master Service Agreement (MSA) for Air Pollution Consulting and Engineering Services for the Authority's St. Croix, St. Thomas, and St. John Generating Facilities located in the U.S. Virgin Islands. A copy of said Contract is attached hereto and made a part hereof as Appendix "A"; and

**WHEREAS**, due to the need for additional air consulting compliance consulting and engineering services while Aggreko comes into compliance with local regulator permit(s), the Contract "Consideration" shall increase in the amount of Four Hundred Thousand Dollars and 00/100 (\$400,000.00). Thereby making the total Contract "Consideration" Six Hundred Thousand Dollars and 00/100 (\$600,000.00).

**NOW THEREFORE**, in consideration of the mutual promises and conditions herein, the Parties, intending to be legally bound, agree as follows:

1. That the Preamble to this Amendment I constitute an integral part thereof;
2. That Section 2 of the Contract entitled "Consideration" shall be amended to increase the Contract "Consideration" in the amount of Four Hundred Thousand Dollars and 00/100 (\$400,000.00), thereby making the total Contract "Consideration" Six Hundred Thousand Dollars and 00/100 (\$600,000.00);

3. That Gross Receipt Taxes shall reflect the amount of Twenty Thousand Dollars and 00/100 (\$20,000.00) shall become due and payable for Gross Receipt Taxes;
4. That these provisions do not usurp, nor in any way change any other terms and conditions of the Contract, except as specifically stated herein; and
5. That except as expressly amended herein, all other terms and conditions of the Contract remain in full force and effect.




