ADDENDUM I

Addendum I to Contract No. SC-11-20 between the VIRGIN ISLANDS WATER AND POWER AUTHORITY (the "Authority") and COMPREHENSIVE SECURITY CONCEPTS, INC. (hereinafter called the "Contractor").

This Addendum I to Contract No. SC-11-20 is entered into on this 23rd day of June ²⁰²⁰ 2020, by and between the Authority and the Contractor. The Authority and the Contractor shall hereinafter be jointly referred to as the "Parties".

WHEREAS, the Parties on November 27, 2019, entered into Contract No. SC-11-20, to provide and operate armed and unarmed security to the satisfaction of the Virgin Islands Water and Power Authority. A copy of said contract is attached hereto and made a part hereof as Appendix "A"; and,

WHEREAS, the Parties agree to amend the scope of work to reflect that the Contractor shall now provide temperature screening services at the Authority's property. Due to this new scope, the consideration shall increase in an amount not to exceed Seventy-Six Thousand Three Hundred Seventy Dollars (\$76,370.00) thereby making the total contract consideration in an amount not to exceed One Million One Hundred Forty-Nine Thousand Four Hundred Thirty-Five Dollars (1,149,435.00).

NOW THEREFORE, in consideration of the mutual covenants herein and the Parties intending to be legally bound hereby, it is agreed as follows:

1. That the preamble to this Addendum I constitute an integral part of the Parties' agreement;
2. Clause 1 entitled "**Scope of Work**" is amended to reflect that the Contractor shall provide temperature screening services at the Authority's property.
3. Clause 2, entitled "**Consideration**" is increased in an amount not to exceed \$76,370.00 thereby resulting in an increase in the total contract consideration under SC-11-20 in an amount not to exceed \$1,149,435.00.
4. Clause 3, entitled "**Gross Receipt Taxes**" shall reflect that an additional sum in the amount of Three Thousand Eight Hundred Eighteen Dollars and Fifty Cents (\$3,818.50) shall become due and payable for Gross Receipt Taxes.
5. That these provisions do not usurp, nor in any way amend the terms and conditions of the Contract, except as specifically stated herein.
