ADDENDUM I

Addendum I to Contract No. SC-12-20 between the VIRGIN ISLANDS WATER AND POWER AUTHORITY (the "Authority") and INTELLIGENT SECURITY (hereinafter called the "Contractor").

This Addendum I to Contract No. SC-12-20 is entered into on this 11th day of July 2020, by and between the Authority and the Contractor. The Authority and the Contractor shall hereinafter be jointly referred to as the "Parties".

WHEREAS, the Parties on November 27, 2019, entered into Contract No. SC-12-20, to provide and operate armed and unarmed security to the satisfaction of the Virgin Islands Water and Power Authority. A copy of said contract is attached hereto and made a part hereof as Appendix "A";

WHEREAS, by letter dated February 25, 2020, the Contractor notified the Authority that effective immediately, Intelligent Security will be conducting business as Vigilant Investigation Services, LLC. A copy of this notice is attached hereto and made a part hereof as Exhibit "A".

WHEREAS, the Parties agree to amend the scope of work to reflect that the Contractor shall now provide temperature screening services at the Authority's property. Due to this new scope, the consideration shall increase in an amount not to exceed Fifty Nine Thousand Nine Hundred Forty Dollars (\$59,940.00) thereby making the total

contract consideration in an amount not to exceed One Million Two Hundred Seven Thousand Four Hundred Twenty-Four Dollars and Twenty-Five Cents (1,207,424.25);

NOW THEREFORE, in consideration of the mutual covenants herein and the Parties intending to be legally bound hereby, it is agreed as follows:

1. That the preamble to this Addendum I constitute an integral part of the Parties' agreement;
2. Clause 1 entitled "**Scope of Work**" is amended to reflect that the Contractor shall provide temperature screening services at the Authority's property;
3. Clause 2, entitled "**Consideration**" is increased in an amount not to exceed \$59,940.00 thereby resulting in an increase in the total contract consideration under SC-12-20 in an amount not to exceed \$1,207,424.25.00;
4. Clause 3, entitled "**Gross Receipt Taxes**" shall reflect that an additional sum in the amount of Two Thousand Nine Hundred Ninety Seven Dollars (\$2,997.00) shall become due and payable for Gross Receipt Taxes;
5. That VIWAPA Consents to the assignment of the Contract SC-12-20 to Vigilant Investigation Services, LLC, which assignment becomes effective upon execution of this document;
6. That the Authority's Consent is neither a modification of, nor an amendment to Contract SC-12-20 except as stated herein, which is and shall remain, in full force;

7. That the Consent nor the Assignment shall in any manner diminish either party's rights under this contract; and
8. That these provisions do not usurp, nor in any way amend the terms and conditions of the Contract, except as specifically stated herein.
